How?	Financial companies need to share customer's personal information to run their everyday business. How does Canyon State Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
How does Canyon State Credit Union collect my personal information?	We collect your personal information, for example, when you  Open an account(s)  Give us your contact information  Apply for a loan  Pay your bills  Make a wire transfer  We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.	
Why can't I limit all sharing?	Federal law gives you the right to limit only  Sharing for affiliates' everyday business purposes – information about your creditworthiness  Affiliates from using your information to market to you  Sharing for non-affiliates to market you  State laws and individual companies may give you additional rights to limit sharing.	
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices apply to everyone on your account.	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.  Canyon State Credit Union has no affiliates.	
Non-Affiliates	Companies not related by common ownership or controls. They can be financial and non-financial companies.  Canyon State Credit Union has no non-affiliates.	
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.  • LPL Financial • Affinion Group • CUNA Mutual Group • First Line Insurance Brokers • CMFG Life Insurance Company
